

# Guide to Information available through Crown Estate Scotland's Publication Scheme

## **PART I**

### **Introduction**

1. The Freedom of Information (Scotland) Act 2002 (the Act) requires Scottish public authorities to adopt and maintain a publication scheme. Authorities are under a legal obligation to:
  - (i) publish the classes of information that they make routinely available;
  - (ii) tell the public how to access the information they publish and whether information is available free of charge or on payment.
2. Crown Estate Scotland has adopted the [Model Publication Scheme](#) produced by the Scottish Information Commissioner. You can find this scheme on our website at <http://www.crownestatescotland.com/freedom-of-information> or by contacting us at the address below.
3. The purpose of this Guide to Information is to:
  - (i) Allow you to see what information is available (and what is not available) in relation to each class;
  - (ii) State what charges may be applied;
  - (iii) Explain how to find the information easily;
  - (iv) Provide contact details for enquiries to get help with accessing information;
  - (v) Explain how to get information we hold that has not yet been published.

### **Environmental Information**

4. We proactively publish our environmental information (for example, policies, plans, programmes, reports and environmental impact studies) when complete. Such information will be published on our website ([www.crownestatescotland.com](http://www.crownestatescotland.com)) or information can be requested by contacting [FreedomofInformation@crownestatescotland.com](mailto:FreedomofInformation@crownestatescotland.com). There may be circumstances when environmental information cannot be published at a particular time due to commercial copyright or sensitivities. In these cases, the reasons for doing so will be communicated.

### **Availability and formats**

5. Information published through the model scheme should, wherever possible, be made available on our website.
6. We offer alternative arrangements for people who do not wish to, or who cannot, access

the information either online or by inspection at our premises. For example, we can usually arrange to send out information in paper copy on request (although there may be a charge for doing so).

### **Exempt information**

7. We will publish the information we hold that falls within the classes of information below. If a document contains information that is exempt under Freedom of Information (Scotland) Act 2002 (for example, sensitive personal data or a trade secret), we may redact the information before publication, and explain why we have done so.

### **Copyright and re-use**

8. Where Crown Estate Scotland holds the copyright in its published information, the information may be copied or reproduced without formal permission, provided that:
  - (i) It is copied and reproduced accurately;
  - (ii) It is not used in a misleading context; and
  - (iii) The source of the material is identified.

Where Crown Estate Scotland does not hold the copyright in information we publish, we will make this clear.

### **Charges**

9. This section explains when we make a charge for our publications and requests for environmental information and how any charge will be calculated.
10. There is no charge to view information on our website or at our premises.
11. We may charge you for providing information by way of CD-Rom, for photocopying or for postage and packaging. Charges will be no more than the actual costs to us. We will always tell you what the cost is before providing the information to you.
12. Our photocopying charge per sheet of paper is 10p per A4 side of paper (black and white) and 20p per A4 side of paper (colour).
13. Information provided on CD-ROM will be charged at 50p per computer disc.
14. Postage costs may be recharged at the rate we paid to send the information to you. Our charge is for sending information by Royal Mail First Class.

15. When providing copies of pre-printed publications, we will charge no more than the cost per copy of the total print run.
16. We do not pass on any other costs to you in relation to our published information.
17. Our charging schedule does not apply to any commercial publications (see class 8 below). If available, these items are offered for sale through retail outlets such as book shops, academic journal websites or museum shops and their price reflects a “market value” which may include the cost of production.
