Hello Alex. I have had sight of your information request. I am afraid that for the time being the condition is not satisfied. There was quite a bit of work done by Marine Harvest in an attempt to satisfy the condition, but it was overtaken by events prior to submission and MH are now in the throes of devising a full Environmental Management Plan with and associated wild fish management strategy to cover both Carradale sites. The latest is that [REDACTED] at [REDACTED] has submitted in the last week or so proposed survey locations/durations/costings to MH for their incorporation into the plan. I hoping for a submission soon and will keep onto them if not.
