Dear All,

First many apologies for the long silence; but some intersessional progress has been made. I would like to canvas your availability for the next meeting over the summer weeks. Please could you fill in the doodle poll here http://doodle.com/s4z9vv5774fm2p6s

Progress

Action Points from last meeting:

- AP: SN to check with IW whether there is any obligation to report deaths of birds or mammals in antipredator nest back to Marine Scotland
 - informs me that under Section 41A of The Conservation (Natural Habitats etc.) Regulations 1994 (as amended) there is an obligation on SNH to monitor the incidental capture or killing of European Protected Species, which includes all cetaceans and otters but not seals. This is mainly directed at bycatch in fisheries but it presumably also covers bycatch in anti-predator nets? It might be worth checking with SNH if there is a system in place that covers this? In respect of birds I have no idea what arrangements might be in place.
 - o I will be following up with SNH; does FF have a policy on this issue?
- AP- **SN** suggested that the group should write to ADD manufacturers to ask what steps they would be taking to ensure that operators can check that their devices are producing the intended acoustic output.
 - Completed. The returned answers to our questions have been collated into one document (attached).
 - PLEASE NOTE THAT MANUFACTURERS HAVE ASKED FOR THESE RESPONSES TO BE TREATED IN COMMERCIAL CONFIDENCE.
- AP: AO and JA to draft letter, SB to supply contact details for manufacturers to JA.
 - Letter was drafted, circulated to group, agreed and circulated to manufacturers all have now responded. Done
- AP: **SN** to ask SNH for a list of which salmon farm sites had been refused permission to use ADD's
 - Ongoing discussion with SNH; no central list exists I am trying to collate what is known.
- AP: **SN** to send AO the latest version of the website copy.
 - o Done
- AP: AO to check the status of the website updates and if there were any modifications needed
 - o Web page copy is with and and hopefully should be available for preview online well before the next meeting; FF has agreed to continue funding carols time and web page hosting fee.
- AP- Working group / sub-group to be reconvened to review actions that need to be fast tracked, and to find ways to facilitate these. **SN** agreed to send an email out to confirm a date between 16th and 20th Dec.
 - Sub-group convened in March in Edinburgh minutes attached

In addition, I have learned from that a trial of the Startle response ADD is being tested 'somewhere in Orkney'. It would be great if those with contacts in the industry might be able to discover more...

Next Meeting


At the next meeting – I would appreciate ideas for the agenda which may include:

These would be far too much to deal with – so opinions on these, or other ideas are welcome.

Finally – location of the meeting: I am aware that the last two meeting have been in Edinburgh and that 8 of the 13 meetings so far have been North of the border – in the hope of encouraging greatest participation; Despite this there were only 7 participants (+6 apologies) at last meeting, 4 of whom travelled up from England. I would appreciate some views on the location of the next meeting.

I think SNH will be unable to attend anywhere much further than the North of England, it would be good to include them, and informs me she may be able to update the group on SNH policy regarding disturbance and European Protected Species licencing. (But this need not necessarily be at the next meeting).
