1. Management of plastic in this reporting period

(i) The comparison of records for the current and previous reporting period indicates that aggregated procurements of **multi-use plastics** deployed on leased sea-sites has <u>decreased</u>.

This <u>decrease</u> was due primarily to the following reasons (*refer to Guidance for completing the Environmental Management of Plastics: Aquaculture Leaseholders Report*).

2023 is the first reporting year, but in comparison to procurement records for multi-use plastics from the previous year, there is a decrease in the total inventory, primarily through the repurposing of some items and the management of stored items at low levels.

(ii) The comparison of records for the current and previous reporting period indicates that our aggregated procurements of **short term/ single-use plastics** used on leased seasites has <u>decreased</u>.

This <u>decrease</u> (please delete as appropriate) was due primarily to the following reasons: (refer to Guidance for completing the Environmental Management of Plastics: Aquaculture Leaseholders Report).

2023 is the first reporting year, but in comparison to previous records, the decrease observed is primarily down to the re-use of the short term plastics, until their end of life has been reached. For SUPs such as cable ties, methodological improvements to the deployment of seeded twine made their sporadic use for this operation obsolete.

(iii) The comparison of records for the current and previous reporting periods indicates that changes to the proportion of waste plastic from leased sea-sites disposed of by recycling, re-use or to landfill are as set out in Table 1 below.

The increases and/or decreases in different disposal means listed in Table 1 are due primarily to the following reasons: (*refer to <u>Guidance for completing the Management of Plastics:</u> <u>Aquaculture Leaseholders Report</u>).*

The relative increase in repurposing of multi-use plastics, with an associated decrease in the disposal of these to landfill, has been primarily through the re-use of sampling equipment such as plastic syringes and bags, and through production equipment with an improved deployment strategy no longer requiring the use of cable ties.

2. Improvements in management of plastics on leased sea-sites

As indicated, improvements have been noted through the increased re-use of plastics, and through an improved deployment strategy.
